Location

Queans Restaurant is located on Dormer Place, close to its junction with the Parade and running alongside the well known Pump Room Gardens. The location of this restaurant is excellent; forming part of the Spa town's impressive period architecture and being in close proximity to the town's prime retail location, beautiful and historic gardens, Leamington Spa Library and Band Stand, Cinema and numerous pubs and bars.


