LOCATION

The subjects are located on Castle Street a thoroughfare with one-way traffic linking High Street to Greenhead within the town centre and are immediately adjacent to Royal Mail premises.

Maybole lies in the South Ayrshire Council area, approximately 8 miles south of Ayr on the A77. The town has a resident population of around 4,500.

Maybole enjoys a reasonable range of local services and facilities, with some multiple retailers including Co-operative Supermarket and the main retail banks within the town centre. Ayr however, is the main shopping and administrative centre for the district and it lies a short distance to the north.
